**One Competition for Each of the Following Age Groups :**

1. 5 years old & Under
2. 6-8 years old
3. 9-12 years old
4. 13-17 years old
5. 18- Adult - NOTE THE ADULT AGE GROUP HAPPENS AT A DIFFERENT TIME/DAY THAN GROUPS 1-4.

**The Winner in each age group will be designated as the person who cleanly shucks the following number of ears first:**

Age Group	Ears of Corn to Shuck
1. 5 years old & Under	1. 3 Ears
2. 6-8 years old	2. 4 Ears
3. 9-12 years old	3. 5 Ears
4. 13-17 years old	4. 6 Ears
5. 18- Adult	5. 10 Ears

1. "Cleaned Shucked" will be defined by the judges of the contest. A demonstration will be given.
2. Awards for the 1st , 2nd, 3rd place winners will be awarded. Age Groups 1 & 2 all receive a Ribbon.
3. In the event of a tie, a runoff contest will be held.
4. All Participants in Groups 1-2 will receive a ribbon.

### One Competition for Each of the Following Age Groups: :

1. Children 5 & Under ( Ear size will be small)
2. 6-8 years of Age (ear Size will be small)
3. Little Ladies 9-12 years of Age
4. Little Lads 9-12 years of Age
5. Girls 13-17 years of Age
6. Boys 13-17 Years of Age
7. 18-ADULT AMATURE LADIES
8. 18- ADULT AMATURE MEN

DUE TO SAFETY SMALLER EARS WILL BE GIVEN TO AGE GROUPS UNDER 12 YEARS OF AGE. WE WILL GIVE A FREE EAR OF CORN TO ANY CHILD UNDER 12 THAT WOULD LIKE TO HAVE ONE BUT NOT PARTICIPATE AS WELL.

1. The winner will be designated as teh person who cleanly eats the most ears wihtin 1 minute. For Groups 3-8. See Rule 8 for Groups 1-2.
2. "Cleanly Eaten" will be defined by the judges of the contest.
3. Awards for the 1st, 2nd, 3rd place winners will be awarded.
4. Amateur first, second and thrid place winners will also recive a cash prizes.
5. In the event of a tie, a runoff contest will be held.
6. All Participants must sign a waiver prior to participating in the competition.
7. Children under 12 years of age must have a parent sign the Waiver and be present during the competition.
8. Age Groups 1-2 will be given a partial ear of corn, the compeition will be eating 1 full ear of corn and whomever "Cleanly Eats" the ear first wins. There will be a 10 minute time out.
9. All Participants in Groups 1-2 will recive a ribbon.
