1. All entries must be submitted prior to show starting time.
2. Entries are encouraged to be sent to The Fair prior to 7/20/25. Pre-Entry required Class 1 thru 8. If interested in a day stall, all stall Monies need to be mailed with Entry Form. (Limited Availability.) **Show Management reserves the right to excuse unruly or dangerous horses or riders that are a hazard to themselves or others.**
3. Show Attire is Required.
4. **All riders under 18 must wear helmet, NYS Law as of 7/31/2013 and classes #32 thru #38**
5. Stalls Available - **\$25.00 Day Charge** -Some Stalls Available Friday Night, August 8th for \$25 • **You are responsible for cleaning your own stall**
6. Judges decision is final.

**MINIATURE COMPEITION RULES:**

1. All Equine under 38" are welcome no registration required.
2. Proof of negative Coggins and Rabies required.
3. Helmets must be worn for all exhibitors 18 and Under while driving.
4. In the event of a tie, Showmanship will be the tie breaker.
5. Show committee has the right to combine or cancel any or all classes.
6. To qualify for year end awards you must show 4 of the 5 shows

**PLEASURE COMPEITION RULES:**

1. Show committee has the right to combine or cancel any or all classes.
2. All classes with 15 or more entries must be split. No stallions allowed in walk/trot, 13 & Under, 14 to 18 & Leadline.
3. Ties will be broken by the horse/rider combination receiving the highest placing in Showmanship.
4. Negative Coggins & Rabies certificate required.
5. No cross entries entering between walk/trot and 3 gaited classes.
6. Age is calculated as of January 1 of the current year for 13 & Under, 14 to 18.
7. To qualify for year end awards you must show 4 of the 5 shows.
8. No cross entering between Ranch horse and Western Pleasure.

**GAMING COMPEITION RULES:**

1. Show committee has the right to combine or cancel any or all classes.
2. Proof of negative Coggins and Rabies required.
3. Helmets must be worn for all exhibitors 17 and Under.
4. To qualify for year end awards you must show 4 of the 5 shows.

**DRESSAGE COMPEITION RULES:**

1. Show committee has the right to combine or cancel any or all classes.
2. Proof of negative Coggins and Rabies required.
3. Helmets must be worn for all exhibitors 17 and Under for Western Dressage.
4. To qualify for year end awards you must show 4 of the 5

**TRAIL COMPEITION RULES:**

1. Show committee has the right to combine or cancel any or all classes.
2. All classes with 15 or more entries must be split. No stallions allowed in walk/trot, 13 & Under, 14 to 18 & Leadline.
3. Ties will be broken by the horse/rider combination receiving the highest placing in Showmanship
4. Negative Coggins & Rabies certificate required
5. No cross entries entering between walk/trot and 3 gaited classes.
6. Age is calculated as of January 1 of the current year for 13 & Under, 14 to 18.
7. To qualify for year end awards you must show 4 of the 5 shows
8. No cross entering between Ranch horse and Western Pleasure Shows.
9. Everyone must wear a helmet for USDF regardless of age.
