REMINDERS & NOTES

- Prices will be locked in at the 2024 vendor rates to vendors who confirm their reservation for the 2025 Fair; All others subject to price increases. Verbal Confirmation will not be accepted. Vendors must have the 2025 Vendor form filled out and payment for 2025 by September 1, 2024.
 - Vendors are required to carry liability insurance. The Fair has insurance options available if needed. Details are included in the vendor form.
 - If you are selling taxable items we require a copy of your NYS Tax # & certificate of authority.
 - Food vendors are required to obtain a NYS department of Health permit to operate a temporary food establishment. Permits can be acquired through the Geneva District office.
 - Dumping of Grease is only permitted in designated areas. Contact Vendor Coordinators if you have any questions.
 - No trash is to be in garbage bags on the ground. It must be placed in garbage containers provided by our sponsor K&D Disposal.
 - Set up time for booths and displays are the weekend before the fair (August 1st, 2nd, 3rd). All booths must be in place by 11 am Monday August 12th, 2024. Any vendors not in place will forfeit payment and be denied access.
 - Fair opens daily at 10am and buildings will be opened daily by 9:30am closed and locked at 9pm.
 - The Fair provides security on the grounds 24 hours a day. The fair also has security cameras on property with limited visibility.
 - We require your booth is in place until Sunday evening at 5 pm. No vehicles will be allowed on exhibit grounds before that time. Any booths removed prior to this will not be allowed back for future events.
 - Absolutely no dogs or pets are allowed on property during fair week. Services dogs are allowed if proper paperwork is presented to a member of the Board of Directors of the fair.
 - Shoes and shirts are required at all times.
 - The Wayne County Fair **does not allow** the sale of guns of any type, poppers and horns. Any vendors selling any sort of guns will be asked to remove them. If they have to be asked to remove them a second time, the vendor will be removed from the property with no refund to their space.
 - The fair will provide all beverages being sold on the grounds provided by the exclusive beverage sponsor, Pepsi. (this is subject to change)

WAYNE COUNTY FAIR FLAIR

In 2024 we launched the Fair Flair Project in an effort to encourage more interaction with vendors. We are encouraging you to participate in Wayne County Fair Flair. This is not required, but the more vendors that participate, the higher the success rate! The requirements to participate are as follows:

Each vendor will offer 1 Wayne County Fair (WCF) themed item, exclusive to the WCF. The item will be sold to consumers throughout the week or until sold out. For example, Food vendors can have a WCF themed menu item like a burger special offered daily, a vendor that sells sox, could offer animal themed sox labeled with the fairs logo, custom magnets. it must be exclusive at the WCF only.

Each participating vendor will receive a sign stating they are part of the program, a figurine to hide in their booth and tokens to give to customers who search and find the figurine. Customers are not required to purchase anything however they are required to engage with you and find the figurine hidden in booth to ensure they receive a token. If they purchase a fair flair item they can receive 1 additional tokens. Tokens can then be brought to the WCF Information Center to be traded for fair swag.

The goal is to engage customers, increase sales and offer them another way to feel like they have participated in the 2024 Wayne County Fair. This is also an opportunity for you to be creative! We want you to come up with fun new items to sell and share with our customers and fairgoers!

BEVERAGE PROGRAM

The Wayne County Fair will provide all beverages being sold on the grounds provided by the exclusive beverage sponsor, Pepsi Cola. If you are selling any of the following beverages, you are required to purchase from the fair. Those products include Gatorade, Pepsi, Diet Pepsi, Starry, Root Beer, Water. We will NOT allow for vendors to sell competitor options as we have a contract and sponsorship with Pepsi.

All orders will be taken daily for next day delivery. Vendors will be billed daily for the beverages and provided an email and printed version of the invoice. Invoices must be paid before closing of Fair on August 12th 2025.

If any customer or vendor does not place an order, they will not receive an order the following business day. If product is needed same day, customers will be able to pick it up from designated location.

Pricing and order forms will be provided 30 days before the start of Fair. Initial deliveries will be provided to you August 9th or when you check in.

The Fair will set the price of drinks. We will provide beverage signage for each vendor with pricing, if needed. Pricing will be provided 30 days before the start of Fair.

Beverages not included in this program (ex. Slushies, milkshakes, shaken lemonades, dairy products and other fresh made items) may continue to be offered by vendors and not required to be purchased through the Fair.

VENDOR CONTRACT

Union Agricultural Society at Palmyra a/k/a. the Wayne County Fair **does not** provide tables or chairs for your use. Vendor set up times will be available **Saturday and Sunday August 2nd & 3rd from 9am to 6pm.** This privilege is accepted upon condition that the business or use above stated is to be conducted in accordance with the Rules and Regulations of the Union Agricultural Society at Palmyra, which are used in transacting the business to which this privilege pertains. We reserve the right to prohibit or limit the use of bullhorns, music, pickets, plaques, demonstrations, etc., inside or outside of your area.

You may not dismantle or remove your display until Sunday August 18th after 5 pm. Penalty is forfeiture of space in the following year. No vehicles are allowed on the Fairgrounds until Sunday August 18, 2024 after 5 pm. The location for said privilege to be assigned by the Society and the business of running such privileges to be conducted to the satisfaction of the Society. Retention of this contract on the part of the purchaser will be taken as evidence of acceptance. The Union Agricultural Society of Palmyra assumes no responsibility for the loss or damage of Lessee's property. Contract subject to Lessee's securing license from Department of Agricultural of this state. (if required). Certificate of Insurance and Certificate of Authority are required. No pets are allowed on the grounds the week of the fair; service animals are allowed on the grounds during the week of the fair with proper documentation. Society reserves the right to reject or terminate any contract at its discretion.

CERTIFICATE OF INSURANCE

Renter will acquire a Certificate of Insurance showing general public liability in the amount of not less than \$1,000,000.00. Union Agricultural Society at Palmyra, NY, a/k/a The Wayne County Fair, must be named as an additional insured on a primary and noncontributory basis. Certificate of insurance must include a 15 day written notice of cancellation to, Union Agricultural Society at Palmyra, NY, a/k/a The Wayne County Fair. All certificates of insurance shall be filed with The Wayne County Fair and must be presented to the Fair's Vendor Superintendent, and the Fair's Insurance Person, on or before 14 days prior to your event. The insurance policy must not be less than \$1,000,000.00 and with insurers authorized to do business in the State of New York.

- Sign should be visible for customers to see
- Rubber Duck should be hidden somewhere in the booth for customers to search for (hopefully encouraging interaction).
- Tokens are to be given to customers who find the duck.

Participating Vendors will commit to providing a Wayne County Fair themed item. Items can include but are not limited to specialty made soaps, candles, ornaments, Food Specials.

Customers will come to the booth for a visit searching for the duck. It will also prompt them to look for the specialty item you are looking for. When they find a duck, they receive a token. If they purchase a specialty fair item they receive 4 tokens
