## ***WAYNE COUNTY FAIR ROYALTY PAGEANT CRITERIA***

### **Eligibility**

- Must live in Wayne County or be part of a Wayne County 4-H Club.
- Must be attending school (public or homeschool).

### **Participation Requirements**

- Winners must attend the Opening Ceremonies, all Grandstand Events, and the Parade during the Fair.
- Other public appearances may be scheduled through November 1, 2026.
- Contestants must follow directions from the Pageant Committee or risk disqualification.

### **Behavior Expectations**

- No alcohol, drugs, smoking/vaping, or swearing during any Fair or pageant events.
- Must behave respectfully and appropriately at all times.
- Arrests or inappropriate behavior may lead to removal from the Royalty Court.

### **Social Media Guidelines**

- Be respectful online, no name-calling or negative posts.
- You must speak respectfully about the Wayne County Fair, the Contestants, and anyone else associated with the Wayne County Fair.
- Misuse of social media can lead to disqualification or loss of title.

### **Conflicts with Other Titles**

- If you currently hold another title that conflicts with Fair duties, you cannot compete until that title ends.

### **Judging Criteria**

- The royalty court is selected based on poise, personality, public speaking skills, interview performance, and formal attire.
- You must prepare a 1-minute speech on a topic that is uplifting and inspiring. (Avoid themes that may be emotional or cause tears)

### **Fees & Fundraising**

- No entry fee!
- Fundraising is done at the Fair all week by selling candy, water, and 50/50 tickets at grandstand events and receiving donations.

### **Parent/Guardian Responsibilities**

- Responsible for the child's attendance throughout fair week and at any other events that may take place.
- Must help with at least one grandstand event. (Sign-up sheets will be available)
- May be asked to assist with public appearances.

**We kindly encourage parents to allow their children the space to explore, make new friends, and fully enjoy the pageant and fair experience independently. Rest assured, a Pageant Committee member will always be present to provide support and supervision.**

### **Additional Info**

- While attendance at all events is not mandatory, **participation in the Opening Ceremonies, the Wayne County Fair Parade, and all grandstand events is required.** A schedule of additional activities will be provided to the winners, and we strongly encourage Royalty members to take part in these opportunities to engage with the community and represent the Fair.
- The Pageant Directors are the final decision-makers for all matters related to the pageant, including rules and discipline.
- Any discrepancies/problems should be reported to the Wayne County Fair Royalty Directors IMMEDIATELY!
